EDUCATION AND INTERNATIONAL EXPERIENCE

The Principal Investigator of the project (Edoardo Lombardi Vallauri, PhD) is a full professor of Linguistics at Università Roma Tre, where he spent most of his academic career. He graduated in Florence under the guidance of Gabriella Giacomelli and Luciano Agostiniani, with a dissertation on "Deictic and determinative: a systematic essay on Piedmontese demonstrative terms". He took a doctorate in Linguistics in Roma under the guidance of Raffaele Simone, with a thesis on "Distribution of information and relations among clauses in written discourse". He studied several months in Vienna with Corrado Grassi and in Santa Barbara (CA) with Wallace Chafe and Sandra A. Thompson. He has been a visiting scholar in many universities, such as Berlin (von Humboldt), Budapest, Castilla La Mancha, Helsinki, Paris VII, Santa Barbara, Tokyo. In some of these, more than once. In particular, he has won 6 long period scholarships (2-3 months) from the Japan Foundation and from the Japan Society for the Promotion of Science, to carry out extensive research projects in Japan on Japanese language issues. On those occasions, he was enrolled as a visiting scholar by major universities (Waseda and Keio) in Tokyo. He has presented communications in some hundred (mainly international) conferences, among which at least 25 times as an invited speaker, and has organized several panels, mainly on the topics involved by the present project.

He is a member of SLI (Italian Society of Linguistics), of SIG (Italian Society of Glottology), of AISTUGIA (Italian Society of Japanese Studies), of SIDG (International Society of Dialectology and Geolinguistics), of AISC (Italian Association for Cognitive Sciences), of IPrA (International Pragmatics Association), of SILFI (International Society of Italian Linguistics and Philology). He is a Member of the Scientific/Editorial Board of the "Italian Journal of Linguistics", of the online journal "CHIMERA- Romance Corpora and Linguistic Studies", of the "Italian Journal of Cognitive Sciences".

He has devoted his main research interests to the following topics:

- CRITICISMS AGAINST THE POVERTY OF THE STIMULUS ARGUMENT AND LINGUISTIC INNATISM;
- JAPANESE LINGUISTICS;
- ITALIAN LINGUISTICS.

Still, he is not a scholar of particularly stable interests, which led him to publish many minor works on other topics. However, the research thread which led the applicant to conceive the present project

is the one that has steadily characterized the whole span of his research activity, beginning with his Doctorate thesis. This short curriculum will concentrate on it.

Recently, he has gathered a group of young scholars who apply his method to measuring implicits in texts, especially for texts whose persuasive aims make their monitoring more useful in a public perspective.
